 - Full Time \$75.00 – For vendors intending to vend every market day of the season.
3. Do not send any monthly fees with this application. Once approved, you will receive further instructions for payment as a vendor.
4. All applications must be received at least **2 weeks** before the proposed set-up date. Applications will be reviewed on a “first-come, first-serve” basis by the Catawba Valley Farmers Market Steering Committee and accepted based on market needs.
